Minutes of Parish Council Meeting held at 7 pm in the Village Hall

TUESDAY 13th January 2026

1. **Councillors present – Cllrs Aked-Walker - Chairman, Lugar-Mawson, Drinkwater, Barrett, Cox and Lowery, Cllr Charles Manners (WNC)**
2. **Apologies approved from: – Cllr Sykes, V Hartley - Clerk (present on phone)**
3. **Members of the public present – Cllr Manners reported from WNC:**
 - i) **Local Plan Consultation** – this has been published, setting out where houses will be built until 2043. Primary and secondary villages will be asked to have some. Confines will be altered slightly. Brackley and Towcester will also take a lot of building which could lead to transport issues. It is important that the plan is agreed by December 2026, otherwise the government could build where they liked in West Northants. WNC has to allow the building of 25% more housing than they have in the past 5 years.
 - ii) **Car Parking Charges** – may be introduced in Towcester and Brackley. Technically charges may only be set for traffic management purposes, not as a general income generation tool.
 - iii) **Potholes** – report potholes through Fix My Street. Encouraged Council to respond to the annual parish consultation survey.

Cllr Lowery stated that the Knightly Way footpath is impassable due to ploughing. Clerk to report to Fix My Street, Cllr Lowery will give Clerk the footpath number.
 - o **Snow and Tree Warden** – to receive update - Cllr Cox reported that there were no issues.
