## **Publication of Highway Maintenance Transparency Reports**

The **Department for Transport** (DfT) has introduced a new requirement for all local highways authorities to **publish information about their highways maintenance activities** to help local taxpayers see the difference that funding is making in their areas. The first report was required to be published on the highways authorities' websites by 30 June 2025 with a copy sent to DfT. Any highway authority not publishing a report by the 30 June deadline risks losing a proportion of their additional funding from government for highway maintenance. ### Withdrawal of Funding for Neighbourhood Plans

As reported in the Friday mini *eUpdate* on 20 June 2025, the government has withdrawn future funding for Neighbourhood Plans. Parish and town councils were able to access up to £10,000 via Locality for neighbourhood planning technical support, which has incentivised and encouraged the development of over 2,400 Neighbourhood Plans in the past decade. Now, sector academic and champion Dr James Derounian has **launched a petition** to reinstate/continue support funding for community-led Neighbourhood Plans. **Rothwell Town Council** has a vacancy for a Town Council Administrator, who will work under the instruction of the Clerk & RFO to ensure the smooth running of the Town Council and Health and Wellbeing Offer. 16 hours per week, Monday to Thursday, £12.50 per hour. Rothwell is an historic town just off the A14, 5 miles northwest of Kettering. There are 6,867 electors and the council has 12 seats. The precept for 2025/26 is £220,000. This is an exciting opportunity to join a growing and progressive town council.

**Collyweston Parish Council** has a vacancy for a Clerk/RFO working 10 hours per week. Collyweston is a small village with 450 electors and is the second most northerly parish in Northamptonshire. The council has 7 seats and the precept for 2025/26 is £31,000. The deadline for applications is **18 July 2025**.
